# **Principal's Report**

As we continue to prioritise student and staff learning and wellbeing while at school, our layered COVID-smart measures will continue for Term 3. These 'baseline measures' are aligned to the NSW Government's general community settings and include:

- staying home and getting tested if unwell, and only attending school when symptom free
- encouraging mask-wearing for all staff and students, particularly in the first 4 weeks of term
- rapid antigen testing for symptomatic students and staff, and close contacts attending school to learn and work
- encouraging COVID-19 vaccinations for students, staff and their families, including a booster shot (when eligible)
- encouraging students, staff and their families to get a flu vaccination
- strict requirements for close contacts attending school
- good hygiene practices
- maximising natural ventilation
- boosted cleaning during the day, with particular attention given to high touch surface areas
- responding to local COVID-19 conditions, when necessary, by working with the Department's Health, Safety and Staff Wellbeing team.

# What's new in Term 3?

As winter continues, our COVID-smart measures have been updated in consultation with NSW Health to provide appropriate protection to our school community.

The department has updated its policy regarding COVID-19 vaccination for employees following an independent risk assessment of school (and corporate) settings and consultation with unions and relevant stakeholders. While vaccination is no longer a requirement for our staff from 1 August 2022, a recent survey highlighted that more than 99% of the Department's active school-based workforce have had at least two doses of a COVID-19 vaccine. The Department will continue to strongly encourage all our staff to keep up to date with their COVID-19 vaccinations as a way of protecting themselves, students, and our school community.

The Department has made a slight change to its cleaning process. Cleaning of school sites will now be more concentrated during the day, with an increase in cleaning in school hours, and a subsequent reduction out of hours. Boosted day cleaning will continue to focus on high-touch areas and other hard surfaces, door handles, light switches and handrails in stairways and movement areas.

# What's continuing for Term 3?

Masks are an effective way of minimising the transmission of respiratory viruses and infections, and protecting our community, especially those who are at higher risk of severe illness from COVID-19 and flu. It is strongly encouraged all students and staff wear a mask for the first 4 weeks of Term 3, particularly in indoor settings or when distancing is not possible. The latest NSW Health advice also recommends wearing a mask for people who have recovered from COVID-19 and recently completed their 7-day isolation period for an additional 3 days (from days 8 to 10 after receiving a positive COVID-19 result). Additionally, as outlined in the below section on close contacts, mask wearing is mandatory for staff and high school students returning to school as close contacts for 5 school days and strongly recommended for primary school students returning to school as close contacts for 5 school days. Students or staff identified as close contacts who are unable to wear a mask will be supported to learn or work remotely.

The Department will send another round of RATs to our school early this term, which we will provide to you in the form of 1 multipack of 5 RAT kits per student. These RATs can be used as required for symptomatic testing, such as if your child is displaying even mild symptoms. Beyond this provision, if you require additional RATs let the school know that you need more and we will try and assist. Additionally, our school will be maintaining a reserve stock of RATs onsite to support symptomatic testing in the event of an outbreak in our school community. Please also remember that positive RAT results must be registered with Service NSW, and students who test positive to COVID-19 must not attend school until their isolation period ends and they are symptom free.

Students identified as close contacts remain able to attend school providing, they are symptom free, notify the school and return a negative COVID-19 test result daily for 5 consecutive school days. Primary students, while not required, are strongly encouraged to wear a mask for 5 consecutive school days (except when eating/drinking or exercising). Please note that students identified as close contacts are still unable to attend overnight excursions, including camps. Visitors identified as close contacts who are engaging directly with students are required to return a negative COVID-19 test result before attending our school and wear a mask.

We will continue to liaise with NSW Health and the Department's Health, Safety and Staff Wellbeing Case Management team to ensure our COVID-smart settings keep up with the latest developments. If local conditions require it, this may mean reintroducing temporary additional COVID-smart measures to act as a 'circuit breaker', including:

- mandating mask wearing for all staff and students in Year 7 and above (high school settings)
- mandating mask wearing for all staff (primary school settings)
- postponing or limiting non-essential activities like excursions, indoor assemblies and visitors to the school
- directing cohorts to learn remotely for short periods of time.

The Department has reviewed environmental differences across NSW as part of their winter ventilation planning to ensure that local climatic conditions at each school are considered. The Department will continue to provide local guidance to schools, including advice on maximising natural ventilation while balancing thermal comfort and the use of indoor and outdoor learning areas for school activities to support schools to adapt to local climate conditions throughout the winter months.

Finally, it is important to note NSW Health's advice to reduce our risk of not only COVID-19, but other illnesses that may affect our school at this time of year such as the flu and respiratory syncytial virus (RSV), both of which can be serious in younger people. We can all protect our loved ones and our community by:

- staying home and getting tested if unwell or displaying any symptoms
- keeping up to date with our vaccinations including the flu vaccine, which is available from your local GP, pharmacy, or Aboriginal Medical Service. Flu vaccines are free for all children aged 6 months to under 5 years, or for a small charge for those aged 5 years and older
- getting tested immediately for COVID-19 if you become symptomatic and isolating until you receive a negative result and are symptom free
- practicing good hand hygiene by washing regularly with soap and water
- taking a RAT before vising vulnerable loved ones or going to large gatherings and events.

### Kinder Enrolments - 2023

We are now taking enrolments for Kindergarten in 2023. If you have a child starting next year or have any friends or neighbours with children planning on starting next year, please contact the front office (43283024) to start the enrolment process.

Children may be enrolled in Kindergarten at the beginning of the school year if they turn five years of age on or before 31 July in that year. By law, all children must be enrolled in school by their sixth birthday. If you are unsure if your child is ready to start school or would like to access further information, please contact the school. As part of the enrolment process, you will need to provide your child's original birth certificate, statement of complete immunisation from Medicare and proof of your current address (a minimum of 100 points of identification are required).

Families are now able to access our online enrolment process to make it easier to enrol your child at your local school. To apply online, your child must be:

- a NSW resident
- an Australian or New Zealand citizen or permanent resident, and
- living in the local enrolment area of the school for which you are submitting an application.

For those families wishing to complete an online application a link can be found via the "About our school - Enrolment" section of the school website. 

# **Assistant Principal and Instruction Update**

Towards the end of Term 2 and across the first few weeks of this term, I have been working with 2P and KC to user-test aspects of the new curriculum that will become mandatory in NSW schools next year in K-2. This is an initiative led by NESA (NSW Education Standards Authority), to allow teachers to provide feedback on the new syllabus documents.

2P have been learning to use their knowledge of friends of ten to add and subtract. We have also started to learn how to bridge through 10 to add numbers using more efficient methods. It has been wonderful to see how quickly students have developed mathematical language to explain their reasoning and strategy choice when solving addition and subtraction algorithms.

In KC students have been unpacking the components of a sentence. They have improved their writing by including adjectives and the conjunction 'and'. There were some very proud teacher moments as students used their phonics knowledge, sentence punctuation and vocabulary to develop compound sentences that described.





During Week 5, Year 1 students will participate in the NSW Department of Education's Year 1 Phonics Screening Check. This is a short assessment that is carried out by classroom teachers to assist them in identifying how students are progressing in phonics.

# Year 1 Phonics Screening Check

# Information for parents and carers

Phonics knowledge and skills are essential for learning to read and write. To be effective readers, students need to learn how to blend sounds together in words quickly so that they can read and understand the meaning.

# About the assessment

The Year 1 Phonics Screening Check is a quick assessment that tells teachers how your child is progressing in phonics.

Phonics is important for students who are learning to read. This screening check observes how your child can read words with different letter combinations.

The main purpose of the Year 1 Phonics Screening Check is to provide your child's teacher with information which will allow them to plan for your child's learning.

Each child is individually assessed by a teacher and all Year 1 students will be assessed.

# Why is phonics important?

To be successful readers, students need to learn the code for the English language - the sounds represented by individual letters or different letter combinations - and the skill of blending these sounds together to read words.

It is important for students to develop quick recall of the sounds represented by different letters and letter combinations, to support successful reading.

Developing blending skills, which is the ability to blend together sounds to read words, is also important. Beginning readers need to learn how to blend sounds together in words quickly and fluently, so as not to disrupt the flow of reading and their comprehension of the text.

### How will I support my child?

Children need frequent opportunities to practise and apply their developing phonics knowledge and skills. You may like to try some of the following activities at home with your child:

- Encourage your child to play games with letters such as bingo, snap or scrabble.
  Support them to say the correct sound represented by individual letters and different letter combinations.
- Practise blending the sounds in simple, one syllable words together. For example, by first pointing to each letter in the word cat and saying each individual sound 'c-a-t', then reading again by blending all the sounds together 'caaaaat', and finally reading the word nice and fast 'cat'. When your child is confident with blending 3 letters together, support them to blend and read 4 letter words like frog (f-r-o-g, fffrrrog, frog).
- Model being a word detective and point out special letter patterns found when reading with your child. For example words with a 'ch' sound on the end are sometimes spelt with the letters tch, like the words match, catch and hatch.
- Support your child's reading success by providing them with plenty of opportunities to practise their phonics knowledge and blending skills by reading decodable books together.
  Decodable books are written using words with letters that your child has learnt. Ask your child's teacher to suggest decodable books with the correct phonics focus for your child.
- When reading books encourage your child to look at the words and 'sound out' any unfamiliar words, blending those sounds together, from left to right, to read the word. This is the best strategy and more helpful than looking at the pictures to guess the meaning.

After payment is made via the Parent Payment System, you will receive an order confirmation email, please keep this for your records.

We will notify you of the date(s) that we run ICAS at the school and when your child's ICAS results are ready. You and your child can access the results once released via the Reports Portal using the TAP ID and pin found on the back of the ICAS certificate.

# FACT SHEET FOR PARENTS, GUARDIANS AND CARERS

# WHAT IS THE NCCD?

NCCD

The Nationally Consistent Collection of Data on School Students with Disability (NCCD) takes place every year.

The NCCD is a collection that counts:

- the number of school students receiving an adjustment or 'help' due to disability
- the level of adjustment they are receiving to access education on the same basis as other students.

Students are counted in the NCCD if they receive ongoing adjustments at school due to disability. This 'help' allows them to access education on the same basis as a child without disability. The NCCD uses the definition of disability in the Disability Discrimination Act 1992.

Schools provide this information to education authorities.

Go to What is a reasonable adjustment? below to learn about adjustments.

# WHY IS THIS DATA BEING COLLECTED?

All schools in Australia must collect information about students with disability.

The NCCD:

- ensures that the information collected is transparent, consistent and reliable
- provides better information that improves understanding of students with disability
- allows parents, guardians, carers, teachers, principals, education authorities and government to better support students with disability.

# Student with disability loading

Funding from the Australian Government for students with disability is based on the NCCD through the student with disability loading.

Students with disability who are counted in the top three levels of the NCCD (extensive, substantial and supplementary) attract the loading. Funding is based on a per-student amount at each of the three levels of additional support. The amount of the loading reflects the level of support students with disability need to participate fully in school, with higher funding for those who need higher levels of support.

Australian Government recurrent school funding is provided as a lump sum to school authorities including state and territory governments, which can then distribute the funding to their member schools according to their own needs-based arrangements.

The Government expects schools and school systems to consider their funding from all sources (ie Australian Government, state and territory and private) and prioritise their spending to meet the educational needs of all of their students, including students with disability.

# WHAT ARE THE BENEFITS OF THE NCCD FOR STUDENTS?

The information collected by the NCCD helps teachers, principals, education authorities and governments to better support students with disability at school.

The NCCD encourages schools to review their learning and support systems and processes. This helps schools to continually improve education outcomes for all students.

# WHAT MUST SCHOOLS DO FOR STUDENTS WITH DISABILITY?

All students have the right to a quality learning experience at school.

Students with disability must be able to take part in education without discrimination and on the same basis as other students. To ensure this, schools must make reasonable adjustments if needed for students with disability. Educators, students, parents, guardians, carers and others (eg health professionals) must work together to ensure that students with disability can take part in education.

The Disability Discrimination Act 1992 and the Disability Standards for Education 2005 describe schools' responsibilities.

# WHAT IS A REASONABLE ADJUSTMENT?

An adjustment is an action to help a student with disability take part in education on the same basis as other students.

Adjustments can be made across the whole school (eg ramps into school buildings). They can be in the classroom (eg adapting teaching methods). They can also be for individual student need (eg providing personal care support).

The school assesses the needs of each student with disability. The school provides adjustments in consultation with the student and/or their parents, guardians and carers.

Schools must make reasonable adjustments if needed. The Disability Standards for Education 2005 define 'reasonable adjustment' as an adjustment that balances the interests of all parties affected.

# WHO IS INCLUDED IN THE NCCD?

The definition of disability for the NCCD is based on the broad definition under the Disability Discrimination Act 1992. The following students are examples of those who may be included in the NCCD if they need monitoring and adjustments:

- students with learning difficulties (such as dyslexia)
- students with chronic health conditions (such as epilepsy or diabetes).

# WHO COLLECTS INFORMATION FOR THE NCCD?

Schools identify which students will be counted in the NCCD. They base their decisions on the following:

- adjustments provided for the student (after consultation with the student and/or their parents, guardians and carers)
- the school team's observations and professional judgements
- any medical or other professional diagnoses
- other relevant information.

School principals must ensure that information for the NCCD is accurate.

# WHAT INFORMATION IS COLLECTED?

A student is counted in the NCCD if they receive reasonable adjustments at school due to disability.

Each year, schools collect the following information about the student, including:

- their year of schooling
- the level of adjustment received
- the broad type of disability.

For students who have more than one disability, the school uses professional judgement to choose one category of disability. They choose the category that most affects the student's access to education and for which adjustments are being provided.

A high level summary of the NCCD data is available to all Australian state and territory governments to improve policies and programs for students with disability.

# HOW IS THIS DATA USED?

The NCCD data informs funding and work by schools and sectors. It ensures that support for students with disability becomes routine in the day-to-day practice of schools. The NCCD also supports students in the following ways.

- The NCCD helps schools better understand their legislative obligations and the Disability Standards for Education 2005.
- Schools focus on the individual adjustments that support students with disability. This encourages them to reflect on students' needs and to better support students.
- The NCCD facilitates a collaborative and coordinated approach to supporting students with disability. It also encourages improvements in school documentation.
- The NCCD improves communication about students' needs between schools, parents, guardians, carers and the community.

The Australian Curriculum, Assessment and Reporting Authority (ACARA) annually publishes high-level, nonidentifying NCCD data.

# WHEN DOES THE NCCD TAKE PLACE?

The NCCD takes place in August each year.

# IS THE NCCD COMPULSORY?

Yes. All schools must collect and submit information each year for the NCCD. This is detailed in the Australian Education Regulation 2013. For more information, ask your school principal or the relevant education authority.

# HOW IS STUDENTS' PRIVACY PROTECTED?

Protecting the privacy and confidentiality of all students is an essential part of the NCCD.

Data is collected within each school. Personal details, such as student names or student identifiers, are not provided to federal education authorities. Learn more about privacy in the Public information notice.


